ADMISSION NOTICE

**Admission into 50% Post Graduate Seats in Government Medical Colleges of Assam and B.B.C.I.,
Guwahati under Assam State Quota after completion of 3rd Round of Online Counselling
for session 2023**

This is for information of all concerned that the provisional select list of candidate after the 3rd round online counselling for 50% Post Graduate seats in the Government Medical Colleges of Assam and B.B.C.I., Guwahati under Assam State Quota for session 2023, has already been published in our official website www.dme.assam.gov.in. The provisionally selected candidates are hereby directed to report for admission into the course in their respective College/ Institutions during office hours on **9th & 10th October, 2023** with following terms & condition, failing which their allotment will be cancelled.

1. All admissions shall be provisional and will be subject to fulfilment of all the requisite eligibility criteria as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021" and court order vide Hon'ble Gauhati High Court order in WP(C) No. 4321 of 2023 (Angshuman Gogoi & 2 Ors. Vs the State of Assam & 2 Ors.)
2. Candidates must bring all necessary Original documents along with Admission and Counselling fees etc. at the time of Admission.
3. Candidates shall have to deposit the original documents as specified in the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021".
4. The candidates who have been re-allotted seats at the time of 3rd counselling are to first collect their original documents with release letter from the respective Principals of the college into which they have got admitted earlier and then only they will report to the Principal of the re-allotted course and college for admission.
5. After admission all candidates shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021" within 2 (two) weeks from the date of admission.
6. A candidate, who furnishes false information/ declaration, his/her admission is liable to be cancelled at any time and proceeding shall be drawn against such candidates under appropriate law including professional conduct etiquette and ethics of National Medical Commission's Regulation.
7. Further, in pursuance of Hon'ble Supreme Court of India Order dated 22/07/2022 in Contempt Petition (C) No. 289 of 2022 in W.P. No. 223 of 2022 and Information Bulletin & Counselling Scheme for 2023 published by Medical Counselling Committee (Point 1.5 at Page 6) it is to be noted that candidates who joined upto round 3 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota.
