5. One certificate from Manager of Tea Garden, where his/her parents/forefather/predecessor worked indicating duration of service and name of the tea garden.
6. Legacy data/ certificate that the predecessor /forefather who worked in the tea garden is linked to the candidate.
7. Self attested photocopy of all the original documents.
8. All duly filled up Annexure I, II, III & VI in Schedule I of MBBS/BDS Admission Rule, 2017.


