**Special Stray Round Counselling and Spot Admission into Post Graduate vacant seats in Government Medical Colleges of Assam under Assam State Quota, session 2023**

In pursuance of letter dated 14/11/2023, vide F. No U-12021/02/2023-MEC issued by the Government of India, this is for information of all concerned that a Special Stray Round Counselling and spot admission into vacant Post Graduate seats available in the Government Medical Colleges of Assam under Assam State Quota for session 2023 will be held on 28<sup>th</sup> November, 2023 (12:00 noon) at the office of the DME, Assam, Sixmile, Khanapara, Guwahati-22, as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 Amended upto 2023" and vide Hon'ble Gauhati High Court order in WP(C) No. 4321 of 2023 (Angshuman Gogoi & 2 Ors. Vs the State of Assam & 2 Ors.)

All Candidates who appeared in NEET-PG-2023 conducted by the National Board of Examinations, New Delhi and who meet the cut-off scores in NEET PG-2023 and are eligible as per "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amended upto 2023)" may participate in the said counselling. Further, the name and NEET PG-2023 Roll No. of the candidate must be present in the Assam State Merit list published by this Directorate.

However, in pursuance of Hon'ble Supreme Court of India Order dated 22/07/2022 in Contempt Petition (C) No. 289 of 2022 in W.P. No. 223 of 2022 and Information Bulletin & Counselling Scheme for 2023 published by Medical Counselling Committee (Point 1.5 at Page 6) it is to be noted that candidates who joined upto round 3 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota and therefore must not participate in this round of counselling.


