This is for information of all concerned that in pursuance of order passed by the Hon'ble Gauhati High Court, Guwahati, vide WP(C) No. 5340/2023, dated 19/09/2023, all TGL/Ex-TGL category candidates who have applied for admission into MBBS/BDS courses in the Government Medical & Dental Colleges of Assam under Assam State quota seats, session 2023, shall have to appear before the State Level Scrutiny Committee at the office of the DME, Assam, Sixmile, Khanapara, Guwahati-22 on 22nd September, 2023 (09:30 am) for verification of documents without fail.

TGL/Ex-TGL category candidates who are provisionally admitted or have been kept withheld into MBBS/BDS courses in the Government Medical & Dental Colleges of Assam, session 2023, shall also have to appear before the State Level Scrutiny Committee on the given date, time & venue without fail.

Documents to be produced during offline verification of documents:

1. NEET-UG-2023 Admit card.
2. ID card (Aadhaar/ PAN card).
3. Caste Certificate (OBC/MOBC-NCL).
4. One certificate from Manager of Tea Garden, where his/her father/forefather/predecessor worked indicating duration of service and name of the tea garden.
5. Legacy data/ certificate that the predecessor /forefather who worked in the tea garden is linked to the candidate.
6. All original documents along with a set of self attached photocopy of all the original documents.

Candidates are directed to regularly visit the official website of this Directorate, www.dme.assam.gov.in for any update.

All concerned Tea garden managers are requested to comply with the Hon'ble Gauhati High Court, Guwahati order and provide necessary certificates as applicable.


