**Stray Round Counselling for Admission into Post Graduate Seats in Government Medical Colleges
of Assam under State Health Service Quota, session 2023**

This is for information of all concerned that a Stray Round Counselling for admission into vacant Post Graduate seats in the Government Medical Colleges of Assam under State Health Service Quota for session 2023, is scheduled to be held on 12th October, 2023 (12 Noon), at the office of the DME, Assam, Sixmile, Khanapara, Guwahati-22.

All interested State Health Service candidates who appeared in NEET-PG-2023 conducted by the National Board of Examinations, New Delhi and who meets the cut-off scores in NEET PG-2023 and are eligible as per "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amended upto 2023)" may attend and participate in the counselling at the venue given above on the schedule date and time. The name and NEET PG-2023 Roll No. of the candidate must be present in the Assam State Merit list published by this Directorate.

Further, in pursuance of Hon'ble Supreme Court of India Order dated 22/07/2022 in Contempt Petition (C) No. 289 of 2022 in W.P. No. 223 of 2022 and Information Bulletin & Counselling Scheme for 2023 published by Medical Counselling Committee (Point 1.5 at Page 6) it is to be noted that candidates who joined upto round 3 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota.

All admissions shall be provisional and will be subject to fulfillment of all the requisite eligibility criteria as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amended upto 2023)" and court order vide Hon'ble Gauhati High Court order in WP(C) No. 4321 of 2023 (Angshuman Gogoi & 2 Ors. Vs the State of Assam & 2 Ors.)


