Admission into 50% Post Graduate State Quota Seats in Government Medical Colleges of Assam and B.B.C.I., Guwahati under Assam after completion of Stray vacancy Round of Online Counselling for session 2023

This is for information of all concerned that the provisional select list of candidate after the Stray vacancy round online counselling for 50% Post Graduate seats in the Government Medical Colleges of Assam and B.B.C.I., Guwahati under Assam State Quota for session 2023, has already been published in our official website www.dme.assam.gov.in The provisionally selected candidates are hereby directed to report for admission into the course in their respective College/ Institutions during office hours on 19th / 20th October, 2023 with following terms & condition, failing which their allotment will be cancelled.

1. All admissions shall be provisional and will be subject to fulfilment of all the requisite eligibility criteria as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amendment upto 2023)" and court order vidé Hon'ble Gauhati High Court order in WP(C) No. 4321 of 2023 (Angshuman Gogoi & 2 Ors. Vs the State of Assam & 2 Ors.)
2. Candidates must bring all necessary Original documents along with Admission and Counselling fees etc. at the time of Admission.
3. Candidates shall have to deposit the original documents as specified in the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amendment upto 2023)".
4. After admission all candidates shall execute a duly registered agreement on a non-judicial stamp paper of applicable value as per the "Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 (Amendment upto 2023)" within 2 (two) weeks from the date of admission.
5. A candidate, who furnishes false information/ declaration, his/her admission is liable to be cancelled at any time and proceeding shall be drawn against such candidates under appropriate law including professional conduct etiquette and ethics of National Medical Commission's Regulation.


