**3<sup>RD</sup> ROUND OFFLINE COUNSELLING FOR SELECTION OF CANDIDATES FOR ADMISSION INTO THE VACANT SEATS OF 1<sup>ST</sup> YEAR DIPLOMA IN PHARMACY (D. PHARM) COURSE IN THE INSTITUTES OF PHARMACY ATTACHED TO THE 3 (THREE) GOVERNMENT MEDICAL COLLEGES OF ASSAM, SESSION 2023**

This is for general information of all candidates who appeared in the Common Entrance Examination, 2023 conducted by the Srimanta Sankaradeva University of Health Sciences for admission into 1<sup>st</sup> year Diploma in Pharmacy (D. Pharm) course in the Institute of Pharmacy attached to the 3 (three) Government Medical Colleges of Assam for the session 2023 that the 3<sup>rd</sup> round offline counselling for selection of candidates for admission into the vacant seats of 1<sup>st</sup> year D. Pharm course is scheduled to be held on 6<sup>th</sup> November/ 2023 as per schedule given below. Candidates applying under various reserved categories are required to produce the appropriate certificates/testimonials etc. in original issued by competent authority before the Selection Board at the time of counselling. The following candidates shown rank-wise and category-wise of Merit list of CEE'2023 who have fulfilled all the eligibility criteria for admission into D. Pharm course are hereby requested to appear in the offline counselling of D. Pharm course session 2023.

Those candidates who already got admitted after 1<sup>st</sup> and 2<sup>nd</sup> counselling and are willing to change their institution as per available vacancy in order of merit may also appear in the 3<sup>rd</sup> counselling.

Candidates who are satisfied with their allotted institution during the 1<sup>st</sup> and 2<sup>nd</sup> counselling need not appear in the 3<sup>rd</sup> round of counselling and their seat in already allotted institution shall remain unchanged.

Candidates not yet admitted must bring with them all original testimonials i.e. Admit Card of CEE-2023, Marks sheets of 10+2 Exam, Admit Card of HSLC examination, Pass Certificates, PRC, Caste certificates and other relevant documents at the time of counselling. The admitted candidates who desire to change their institution shall have to produce their admission receipt at the time of counselling.


