With reference to the subject cited above, I am to enclose herewith a copy of the Director of Medical Education, Assam's letter mentioned above under reference regarding reservation of 5 % of MBBS/ BDS seats reserved for those students, who studied from class VII to X in Government/ Prov. Schools of Assam under SEBA and Class XI and XII in the Govt./Prov. Schools of Assam under AHSEC.

In this connection, it is stated here that the Director Medical Education, Assam has prepared a format of application to be filled up by the candidates for applying for the above mentioned reserved seats.

You are, therefore hereby Nominated as Verifying Officer of your District for verification of the eligibility of candidates who passed from Assam State Govt./Provincialised Schools.

The following instruction is hereby issued for the purpose;

- Students, who have studied in the premises of Govt./ Provincialised Secondary Schools from class VII to X under SEBA and Govt./ Provincialised Higher/ Sr. Secondary Schools from class XI and XII under AHSEC shall only be eligible for the above mentioned reserved seats.
- Students, who did not study in the Govt./ Provincialised Institutions though registered their names in the Institution just for appearing in the HSLC/ HSSLC Examination shall not be eligible for the above mentioned reserved seats.
- To facilitate the students for applying 5 % reservation of MBBS/ BDS seats, initially the Head of the Institution shall verify the students, who applied for the above mentioned reserved seats and same will be forwarded to the office of the Inspector of Schools for re-verification and countersignature.
- Inspector of Schools of the concerned District shall re-verify the name of the student as received from the Head of the Institution and countersigned the format.
