SECOND ROUND COUNSELING FOR SELECTION OF CANDIDATES FOR ADMISSION INTO 1ST YEAR DIPLOMA IN PHARMACY (D. PHARM) COURSE IN THE INSTITUTE OF PHARMACY ATTACHED TO THE 3 (THREE) MEDICAL COLLEGES OF ASSAM, SESSION 2020

This is for general information of all candidates who appeared in the Common Entrance Examination, 2020 conducted by the Srimanta Sankaradeva University of Health Sciences for admission into 1st year Diploma in Pharmacy (D. Pharm) Course in the Institute of Pharmacy attached to the 3 (three) Medical Colleges of Assam for the session 2020 that the 2nd round counseling for selection of candidates for admission into 1st year D. Pharm course is scheduled to be held on 24th August/2021 through Online based Platform (Zoom). The following candidates shown Rank-wise and category-wise of Merit list of CEE'2020 who have full filled all the eligibility criteria for admission into D. Pharm course are hereby requested to appear in the Online based Platform (Zoom) counseling of D. Pharm course session 2020.

- (A) All candidates secured Rank upto 363 of CEE'2020.
- (B) All candidates who have applied under Physically Handicapped Quota.
- (C) Candidates belonging to OBC/MOBC Category Rank upto 520 of CEE'2020.
- (D) Candidates belonging to SCHEDULED CASTE category Rank upto 1064 of CEE'2020.
- (E) Candidates belonging to ST(P) category Rank upto 802 of CEE'2020
- (F) Candidates belonging to TGL/Ex-TGL Category Rank upto 976 of CEE'2020
- (G) Candidates belonging to E.W.S. Quota Rank upto 393 of CEE'2020

Those candidates who already got admitted after 1st counseling and are willing to change their institution as per available vacancy in order of merit may also appear in the 2nd counseling.

Candidate who are satisfied with their allotted institution during the 1st counseling need not appear in the 2nd round of counseling and their seat in already allotted institution shall remain unchanged.

Candidates not yet admitted must keep with them all original testimonials i.e. Admit Card of CEE-2020, Marks sheets of 10+2 Exam, Admit Card of HSLC examination, Pass Certificates, PRC, Caste certificates and other relevant documents at the time of online counseling. The admitted candidate who desire to change their institution shall produce their admission receipt at the time of online counseling.
