**ADMISSION NOTICE**

**2<sup>nd</sup> Counseling for Selection and Spot Admission into the Post Graduate Courses in the 4(four) Medical Colleges of Assam for the Session 2017.**

It is for general information of the all candidates that the 2<sup>nd</sup> counseling and spot admission into the Post Graduate courses in the four Medical Colleges of Assam for the session 2017 is fixed as per schedule mentioned below. Candidates whose names have appeared in the State of Assam merit list of NEET-P.G.-2017 conducted by the National Board of Examination, New Delhi and who are qualified in the said merit list as well as who have fulfilled all the eligibility criteria for admission into P.G. courses as per Assam P.G. Admission rules are hereby requested to physically appear for the counseling and spot admission as per schedule mentioned below. Candidates who have already been admitted as per 1<sup>st</sup> counseling may also appear the 2<sup>nd</sup> counseling for change of course and College against available vacant seats as per merit position.

1. All candidates of Un-reserved, Reserved category and N.E.C. candidates securing 50% marks and above in the State of Assam merit list of NEET-P.G.-2017.

The candidates who secured minimum 50% marks after awarding 3% additional marks as per P.G. admission rule should appear in the counseling.

1. State Health Service quota candidates Securing 50% marks and above in the State of Assam merit list of NEET-P.G.-2017 under **General** Category and securing 40% marks and above in the State of Assam merit list of NEET-P.G.-2017 under **SC/ ST(P)/ ST(H) & OBC/MOBC** Category.
2. Candidates under **SC/ ST(P)/ ST(H) & OBC/MOBC** category securing 40% marks and above in the State of Assam merit list of NEET-P.G.-2017.

**IMPORTANT :-**

- A) The State Health Service Quota candidates must bring original letter issued by Joint Director of Health Services, Assam of the concerned district countersigned by the Director of Health Services, Assam/ Director of Health Services (FW) Assam certifying their rural service at the time of counseling. The format of said certificate are available in this Office website [www.dmeassam.gov.in](http://www.dmeassam.gov.in).
- B) The Candidates should come prepared for on the spot admission at the same time, date & venue of counseling along-with necessary admission fees/ counseling fees.
- C) Candidates shall have to deposit the original documents as specified in Assam Medical College (Regulation of Admission to Post Graduate Courses) Rules, 2006 (Amendment up to 2012)
- D) After being selected the candidates admitted under State Quota seat including candidates of State Health Services Quota shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2006 (Amended upto 2012) at the time of spot admission. Necessary fee for registration of Agreement etc. shall have to be born by the candidates at time of admission.
- E) A candidate, who furnish false information/ declaration to the Selection Board or in the Declaration Form his/her admission is liable to be cancelled at any time and proceeding shall be drawn against such candidates under appropriate law including professional conduct etiquette and ethics of Medical Council of India's Regulation.
- F) Candidates must be able to show their Permanent Registration Certificate, certificate for Completion of one year Rural Service in Assam etc. at the time of counseling, otherwise they shall not be eligible for admission as per provision of admission Rules.
- G) All selection/ Admission shall be provisional.
- H) The Candidates, who are in Government Service shall be admitted provisionally and they shall have to obtain a release order within 15(fifteen) days from the date of admission.
