**ADMISSION NOTICE**

**Mop up Counseling for Selection and Spot Admission into the Post Graduate Courses against vacancy in the 4(four) Medical Colleges of Assam for the Session 2017.**

It is for general information of the all candidates that as per letter of Ministry of Health & Family Welfare, Govt. of India vide F. No.V.11011/1/2015-Mep a Mop up counseling and spot admission into the Post Graduate courses in the four Medical Colleges of Assam for the session 2017 will held on **31<sup>st</sup> May/2017 at Office of the Director of Medical Education, Assam, Sixmile, Khanapara, Guwahati-22 at 12-00 am.** Candidates whose names have appeared in the State of Assam merit list of NEET-P.G.-2017 conducted by the National Board of Examination, New Delhi and who are qualified in the said merit list as well as who have fulfilled all the eligibility criteria for admission into P.G. courses as per provision of Assam P.G. Admission rules,2006 (Amendment upto 2012) are hereby requested to physically appear for the counseling and spot admission as per schedule. Candidates who have already been admitted as per 1<sup>st</sup> & 2<sup>nd</sup> counseling may also appear the Mop up counseling for change of course and College against available vacant seats according to merit position.

**The up to date merit list (Merit position of candidates) after awarding 3% additional marks have been uploaded in the Office website [www.dmeassam.gov.in](http://www.dmeassam.gov.in) .**

The Candidates should come prepared for on the spot admission at the same time, date & venue of counseling along-with necessary admission fees/ counseling fees etc.


After being selected, the candidates shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2006 (Amended upto 2012) at the time of spot admission. Necessary fee for registration of Agreement etc. shall have to be born by the candidates at time of admission.

The other terms and conditions shall remain same as per Admission Notice of 1<sup>st</sup> & 2<sup>nd</sup> counseling of Post Graduate courses, session 2017.

Vacancy of seats may arise lately due to surrender of seats by candidates both State & AIQ upto 5 pm of 31/05/17. Therefore the candidates are requested not to leave the counseling hall before completion of the counseling process, so that they may claim for the vacant seat/seats arise (if any).

**IMPORTANT NOTE :-**

In Pursuance of Ministry & Health and Family Welfare, Govt. of India letter F.No.V.11025/18/2017-MEP, dated 24<sup>th</sup> May/2017, the percentile cut offs for NEET-PG.2017 has been reduced by 7.5 Percentile, taking them to 42.5 percentile for general candidates , 32.5 percentile for reserved category candidates and 37.5 for PH category candidates. Accordingly, the candidates who becomes qualified now may also attend the counseling.
