**ADMISSION NOTICE**

**1<sup>st</sup> Counseling for Selection and Spot Admission into the Post Graduate Courses in the 4(four) Medical Colleges of Assam for the Session 2018.**

It is for general information to the candidates that the 1<sup>st</sup> counseling and spot admission into the Post Graduate courses in the four Medical Colleges of Assam for the session 2018 is fixed as per schedule mentioned below. Candidates whose names have appeared in the State of Assam merit list of NEET-P.G.-2018 conducted by the National Board of Examination, New Delhi and who are qualified in the said merit list are hereby requested to appear for the counseling and spot admission as per schedule mentioned below.

**Date of Counseling**

**Candidates to appear in counseling**

- 03-04-2018. 1. All candidates of Un-reserved, Reserved including State Health Service quota & N.E.C quota candidates whose names have appeared in the State of Assam merit list of NEET-P.G.-2018 and securing 500 marks and above in the said merit list.

The candidates who are qualified in the merit list of NEET-P.G.-2018 and have secured minimum 500 marks after awarding 3% additional marks as per P.G. admission rule they should appear in the counseling on this day.

2. **Physically Handicapped Candidates:** All Qualified candidates whose names have appeared in the State of Assam merit list of NEET-P.G.-2018 and secured 300 marks or above.

(The counseling process if not completed on this day the remaining candidates shall have to appear in the next day i.e. 04/04/2018 at 10.30 am. Candidates are requested to get prepared accordingly)

- 04-04-2018. 1. The candidates of O.B.C./M.O.B.C. category and State Health Service quota whose names have appeared in the State of Assam merit list of NEET-P.G.-2018 and securing below 500 marks and above 428 Marks in the said merit list.

2. The candidates of S.C, S.T.(P), S.T.(H) category whose names have appeared in the State of Assam merit list of NEET-P.G.-2018 and securing below 500 marks and above 281Marks in the said merit list.

(The counseling process if not completed on this day the remaining candidates shall have to appear in the next day i.e. 05/04/2018 at 10.30 am. Candidates are requested to get prepared accordingly)

At 10.30 AM onwards.

**IMPORTANT :**

A) The N.E.C. quota candidates shall have to obtain a certificate from the N.E.C. Secretariat for this purpose. The format of said certificate are available in this Office website [www.dme.assam.gov.in](http://www.dme.assam.gov.in).

B) The State Health Service Quota candidates must bring original letter issued by Joint Director of Health Services, Assam of the concerned district countersigned by the Director of Health Services, Assam/ Director of Health Services (FW) Assam certifying their rural posting at the time of counseling. The format of said certificate are available in this Office website [www.dme.assam.gov.in](http://www.dme.assam.gov.in).

C) The Candidates should come prepared for on the spot admission at the same time, date & venue of counseling along-with necessary admission fees/ counseling fees etc.



D) Candidates shall have to deposit the original documents as specified in Assam Medical College (Regulation of Admission to Post Graduate Courses) Rules, 2006 (Amendment up to 2012)

E) After being selected the candidates admitted under State Quota seat including candidates of State Health Services Quota shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2006 (Amended upto 2012) at the time of spot admission. Necessary fee for registration of Agreement etc. shall have to be born by the candidates at time of admission.

F) A candidate, who furnish false information/ declaration to the Selection Board or in the Application Forms his/her admission is liable to be cancelled at any time and proceeding shall be drawn against such candidates under appropriate law including professional conduct etiquette and ethics of Medical Council of India's Regulation.

G) Candidates must be able to show their Permanent Registration Certificate, certificate for Completion of one year Rural Service in Assam etc. at the time of counseling, otherwise they shall not be eligible for admission as per provision of admission Rules.

**NOTE:**

- 1) A candidate selected and admitted into a particular subject on the day of counseling shall not be allowed to change his/her subject or College under any circumstances.
- 2) Those candidates who applied for 3% addl. Marks they shall not be eligible for addl. 3% marks if they are not qualified in the NEET-P.G.-2018.
- 3) All selection/ Admission shall be provisional.
- 4) The Candidates, who are in Government Service shall be admitted provisionally and they shall have to obtain a release order within 15(fifteen) days from the date of admission.
- 5) The break-up of seats will be displayed at the time of counseling.
- 6) The approximate admission fees would be Rs. 30,000/- (Rupee Thirty thousand) only.
