EDUCATIONAL NOTICE

1st Round of Counseling for Admission into 50% Post Graduate Seats in Medical Colleges of Assam under Assam State Quota, session 2021

This is for information of all concerned that the 1st Round of Counseling for Admission into 50% Post Graduate Seats in Medical Colleges of Assam under Assam State Quota for the session 2021 is going to be held under this Directorate in accordance of letter No. F.No. U-12021/06/2021-MEC dated 10.01.2022 from MCC, DGHS, New Delhi. Candidates who appeared in NEET-PG-2021 conducted by the National Board of Examinations may participate in the Online counseling provided they fulfill all the eligibility criteria mentioned in the Medical Colleges of Assam (Regulation of Admission into Post Graduate Degree and Diploma Courses) Rules, 2021 as well as meet the cut-off scores in NEET PG-2021. Further, except for the NEC sponsored candidates, the name and NEET PG-2021 Roll No. of the candidate must be present in the updated provisional revised merit list of eligible candidates published by this Directorate vide Addendum No. DME/ PG/87/2021/442 dated 13/01/2022.

Online Registration for the counseling shall commence from **16/01/2022 to 19/01/2022 midnight**, which will be available in the official website of this Directorate, www.dme.assam.gov.in. After completion of Online Registration process, Online Filling of Choices shall be available from **21/01/2022 to 23/01/2022 5 PM**, after which the choices will be locked automatically if not locked earlier by the candidate. After processing the data, a college-wise and subject-wise list of selected candidates shall be displayed along with modalities of admission. The selected candidates shall have to proceed to the allotted institution for spot verification of their original certificates/testimonials and shall be provisionally admitted in the course if found to be eligible.

The counseling will be held subject to the order/s to be passed by the Hon'ble Gauhati High Court on 18/01/2022 and thereafter in WP(C) No. 211/2022 (Dr. Masumi Ahmed & 15 Ors Vs State of Assam & Ors).

Candidates are directed to visit the official website of this Directorate, www.dme.assam.gov.in regularly for updates.


