2ND ROUND COUNSELLING FOR ADMISSION INTO VACANT SEATS OF 1ST YEAR MBBS/BDS COURSES IN THE MEDICAL & DENTAL COLLEGES OF ASSAM **UNDER ASSAM STATE QUOTA, SESSION 2020**

This is for information of all concerned that the 2nd Round of online Counselling for Admission into the vacant seats of 1st year MBBS/BDS courses in the Medical & Dental Colleges of Assam under Assam state quota and seats reverted back from 15% All India Quota (AIQ) for the session 2020, is going to be held under this Directorate. Candidates who appeared in NEET-UG-2020 conducted by the National Testing Agency (NTA) may participate in the Online counselling provided they fulfil all the eligibility criteria mentioned in the Medical Colleges and Dental Colleges of Assam, (Regulation of Admission into 1st year MBBS/BDS courses) Rules, 2017 with subsequent amendments up to 2020 and Government of Assam notifications issued in this regard as well as meet the cut-off scores in NEET UG-2020. Further, it is essential that the name of the candidate with NEET UG-2020 Roll No. must be present in the list of eligible candidates published by this Directorate earlier as ASSAM STATE NEET-UG MERIT LIST FOR MBBS/BDS COURSES, SESSION-2020 in its website. Candidates who have already joined in their allotted seats in Round-2 under 15% All India Quota cannot participate in the 2nd round of counselling for State Quota seats.

Online Registration for the 2nd round of counselling for vacant State quota seats will commence from 10/12/2020 to 12/12/2020 midnight, which will be available at the official website of this Directorate, www.dme.assam.gov.in. Candidates who have already participated in 1st Round of State Counselling need not register again and can participate in the 2nd Round Online Counselling by online filling and locking choices afresh. Online Filling of Choices and Locking of Choices will be available from 14/12/2020 to 16/12/2020 midnight, after which the choices will be locked automatically if not locked earlier by the candidate. Candidates, who registered for 1st or 2nd Round of Online Counselling but did not fill choices in the 2nd round of counselling, will not be considered for allotment of seats in the 2nd round of Online Counselling. A list of selected candidates along with modalities of admission will be displayed in the website of this Directorate on 19/12/2020. The selected candidates will have to get admitted in the respective institutions as directed and pay the requisite fees along with counselling fees at the time of admission.

Further, it has been observed that few candidates who claimed to be from reserved categories could not produce proper category certificates during document verification. A last and final option has therefore been given to these candidates to change their category to General Category which they may do during the Online Registration from 10/12/2020 to 12/12/2020 midnight by logging in to their own Account. Similarly, a last and final option has also been given to OBC/MOBC-NCL candidates to correct their subcategory if they had mistakenly clicked in some other subcategory during 1st round Registration, which they may do during the Online Registration from 10/12/2020 to 12/12/2020 midnight by logging in to their own Account. Except those mentioned here, no other Category change will be allowed.
