EDUCATIONAL NOTICE

Regarding eligibility criteria for admission into 1st year M.B.B.S. / B.D.S. courses in the Medical Colleges of Assam session 2021.

It is for the general information of all concerned that in view of the striking down of rule 4(2)(b) and rule 4(2)(c) of Medical Colleges and Dental Colleges of Assam (Regulation of Admission into 1st year MBBS/BDS courses) Rules 2017 by the Hon'ble Gauhati High Court, Guwahati through its order in connection with the case No. W.P.(C). 4683/2019, the rule 4(2)(b) and rule 4(2)(c) of Medical Colleges and Dental Colleges of Assam (Regulation of Admission into 1st year MBBS/BDS courses) Rules 2017 will not be applicable for admission into MBBS and BDS courses of Medical Colleges and Dental Colleges of the State of Assam for the session 2021.

As such, for the session 2021, admission in to Medical Colleges and Dental Colleges of the State of Assam will now be guided by the Qualification criteria laid down by National Testing Agency (NTA) at Point 4.4. of the Information Bulletin for admission to Undergraduate Medical courses of NEET-(UG)-2021. The other eligibility criteria of Medical Colleges and Dental Colleges of Assam (Regulation of Admission into 1st year MBBS/BDS courses) Rules 2017 (Amendment upto 2020) will remain same.
