Applications are invited in plain paper from the candidates intending to undergo 4 (Four) years Degree in following courses session 2022-23 at Regional Institute of Paramedical and Nursing Sciences, (RIPANS) Aizawl, against seats allotted to the Govt. of Assam.

1.	B. Sc (N)	-	4 seats
2.	B. Sc - MLT	-	3 seats
3.	B. Pharm	-	3 seats
4.	B. Sc- RIT	-	3 seats
5.	B. Optometry	-	3 seats

Eligibility Criteria:

1. For admission into B. Pharm course the A.I.C.T.E. Admission Regulation specified that Admission in the Degree in Pharmacy shall be 10+2 passed in Science stream Exam with a minimum aggregate of 50% of marks in PCB/ PCM and English or passed in Diploma in Pharmacy with a minimum aggregate of 50%. Relaxation of marks by 5% for the candidates belonging SC/ST/OBC is admissible.
2. The entry level of B. Sc (N), B. Sc-MLT, B. Sc-RIT & B. Optometry shall be 10+2 passed in Science stream Exam with a minimum aggregate of 50% marks in PCB and English and must have passed in each subjects. Relaxation of marks by 5% for the candidates belonging SC/ST/OBC is admissible.
3. The candidate must be a permanent resident of Assam.

5. Age as on 31/12/2022.
6. Permanent address.
7. Marks obtained and year of passing of HS (+2) examination.

11. Percentage (%) of marks in PCB or PCM and English for B. Pharm course and PCB and English for other courses.
12. Details of marks scored in HS (+2) examination.

NB: Applicants must furnish all the above mentioned information correctly; application with incomplete information may be rejected.

1. Permanent Residential Certificate.
2. Address proof.
3. Mark sheet & Pass certificate of HSLC/CBSE class (X) & HS (10+2) (Sc) examination.
4. Admit card or others documents in support of age proof.

6. Caste Certificate (if belong to SC/ST/OBC).
