1st Round Counselling for Admission into 50% Post Graduate Seats in Medical Colleges of Assam under Assam State Quota, session 2020

This is for information of all concerned that the 1st Round Counselling for Admission into 50% Post Graduate Seats in Medical Colleges of Assam under Assam State Quota for the session 2020 is going to be held under this Directorate as per Notice issued by the Government of India/ MCC/ MCI, vide Notification No. U-12021/44/2019/21-MEC, dtd. 17/04/2020. Candidates who appeared in NEET-PG-2020 conducted by the National Testing Agency may participate in the Online counselling provided they fulfil all the eligibility criteria mentioned in the Assam Medical Colleges (Regulation of Admission to Post-Graduate Courses) Rules, 2006 and all subsequent Amendments as well as meet the cut-off scores in NEET PG-2020. Further, except for the NEC sponsored candidates, the name and NEET PG-2020 Roll No. of the candidate must be present in the list of eligible candidates published by this Directorate.

Online Registration for the counselling will commence from 25/04/2020 to 28/04/2020 midnight, which will be available at the official website of this Directorate, www.dme.assam.gov.in. After completion of Online Registration process Online Filling of Choices will be available from 30/04/2020 to 02/05/2020 midnight, after which the choices will be locked automatically if not locked earlier by the candidate. After processing the data, a college-wise and subject-wise list of selected candidates will be displayed along with modalities of admission. The selected candidates will have to get admitted in the respective institutions as directed and pay the requisite fees along with counselling fees at the time of admission.

Candidates are directed to visit the official website of this Directorate, www.dme.assam.gov.in regularly for updates.


