2nd Round Counselling for Admission into vacant Post Graduate Seats in Medical Colleges of Assam and B.B.C.I., Guwahati under Assam State Quota, session 2020

This is for information of all concerned that the 2nd Round of online Counselling for Admission into the vacant Post Graduate Seats in Medical Colleges of Assam and B.B.C.I., Guwahati under Assam State Quota and seats reverted back from 50% All India Quota (AIQ) for the session 2020, is going to be held under this Directorate. Candidates who appeared in NEET-PG-2020 conducted by the National Board of Examination may participate in the Online counselling provided they fulfil all the eligibility criteria mentioned in the Assam Medical Colleges (Regulation of Admission to Post-Graduate Courses) Rules, 2006 and all subsequent Amendments as well as meet the cut-off scores in NEET PG-2020. Further, except for the NEC sponsored candidates, the name and NEET PG-2020 Roll No. of the candidate must be present in the list of eligible candidates published by this Directorate earlier. The candidates who have already joined in their allotted seats in Round-2 under 50% AIQ cannot participate in the 2nd round of counselling for 50% State Quota seats.

Online Registration for the counselling will commence from 06/07/2020 to 07/07/2020 midnight, which will be available at the official website of this Directorate, www.dme.assam.gov.in. The candidates who have already participated in round 1 state counselling need not register again. After completion of Online Registration process, Online Filling of Choices will be available from 09/07/2020 to 12/07/2020 midnight, after which the choices will be locked automatically if not locked earlier by the candidate. After processing the data, a college-wise and subject-wise list of selected candidates will be displayed along with modalities of admission on 16/07/2020. The selected candidates will have to get admitted from 17/07/2020 to 19/07/2020 in the respective institutions as directed.

Candidates are directed to visit the official website of this Directorate, www.dme.assam.gov.in regularly for updates.


