All new candidates called up for Mop-up counseling must bring the Application Form (Schedule-I) in original, duly and properly filled in, Marks sheets of 10+2 (Sc.) examination, Admit Card of HSLC examination, Pass Certificates of HSLC & 10+2 (Sc) exam, PRC, Caste certificates, EWS certificate, Admit card & Score card of NEET(UG) 2020 and other relevant documents in original. A set of photo copies of all the said documents signed by the candidate himself/herself are to be submitted along with the Application Form (Schedule-I) at the time of counseling. The said application Form- Schedule-I shall be available in our official website www.dme.assam.gov.in. Incomplete application Form shall be summarily rejected.

The candidates who had already submitted the complete Application Form (Schedule-I) at the time of admission during 1<sup>st</sup> and 2<sup>nd</sup> round of counseling need not submit the same. However, they shall have to produce the admission acknowledgement receipt at the time of Mop-up round of counseling.

Candidates must appear physically for counseling on the scheduled dates and time, failing of which no seat shall be allotted in this counseling.

Counseling fees Rs.1000/- (Rupees one thousand) only in cash shall have to be paid at the time of counseling.
