Provisional Admission Notice after completion of Mop-up Round of Online Counselling for Admission into 50% State Quota Post Graduate vacant Seats in Government Medical Colleges/ Institutes of Assam, session 2021

This is for information of all concerned that the provisional select list of candidate in the Mop-up round of online counselling for admission into the 1st year Post Graduate courses in the Government Medical Colleges/ Institutes of Assam under 50% State quota vacant seats has already been published in our official website www.dme.assam.gov.in. The selected candidates are hereby directed to report for admission into the Post Graduate course in their respective College/ Institutions during office hours on 6th / 7th May, 2022 with following terms & condition, failing of which their allotment will be cancelled.

1. All the admission shall be provisional and it will be subject to fulfilment of all the requisite eligibility criteria as per the Assam Medical College (Regulation of Admission to Post Graduate Courses) Rules, 2006 and subsequent amendments.
2. Candidates must bring all necessary original documents along with Admission and Counselling fees etc. at the time of Admission.
3. Candidates who were admitted into the PG courses session 2021 after 2nd round of counselling and re-allotted PG seats in the Mop-up counselling of state quota seats, their earlier seats and institution shall automatically cancelled.
4. The candidates who have been re-allotted seats at the time of Mop-up counselling are to first collect their original documents with release letters from the respective Principals of the college into which they have got admitted earlier and then only they will report to the Principal of the re-allotted college for admission.
5. Candidates shall have to deposit the original documents as specified in the Assam Medical College (Regulation of Admission to Post Graduate Courses) Rules, 2006 and subsequent amendments.
6. After admission all candidates shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2006 with subsequent amendments within 2 (two) weeks from the date of admission.
7. A candidate, who furnishes false information/ declaration at the time of online selection or admission, his/her admission is liable to be cancelled at any time and proceeding shall be drawn against such candidates under appropriate law including professional conduct etiquette and ethics of National Medical Commission's Regulation.
8. Candidates who have already taken admission under 50% All India Quota must produce a copy of resignation/ surrender acceptance letters from the respective College/ Institutes for admission.
9. The admission fee varies from different Colleges/Institution. Candidates are therefore requested to communicate with the respective College/ Institution for collecting information regarding Admission fee, etc.

It is also for information of all the concerned that offline counseling for selection of candidates for admission into PG courses in the Government Medical Colleges of Assam against vacant seats under State Health Service Quota (SHQ) and Stray Round of Counseling and Spot Admission if any vacancy arise for the session 2021 is scheduled to be held on 8th May, 2022 at 11.00 am at the office of the undersigned. All eligible candidates are directed to appear physically before the PG Selection Board as per schedule with all original testimonials.


